Photo Contest

The Committee on International Affairs of the Student Union the ESN Debrecen and the AIESEC Debrecen whom all organizes the event of the Global Tower hereby announces a Photo Contest.

1 The description of the photo contest

The Photo Contest officially will start on the 23rd of April 2019 at 12 pm, and it ends on the 30th of April 12:00 pm.

You can apply for the Photo Contest by filling out the registration form which can be found at the following link.

One picture can only be sent to one category. If one picture is sent in more than one category, then we only recognize the one which was uploaded first.

The categories are the following:

- Perks of being on Exchange
- My Debrecen
- Uni Life

Besides the winners of the categories above, the best ten pictures will be exhibited at the Nagyerdei Víztorony (Water Tower) during the Global Tower event. Because of this, the applicants must undertake that the organizers will print their pictures and exhibit it so that participants may look at it and take any photo or video recording of it.

The organizers of the Photo Contest are the Committee on International Affairs of the Student Union (from now on „DEHÖK EHKB”) and AIESEC Debrecen. It is DEHÖK EHKB who conduct the Photo Contest and the data handling.

1.1 Prizes

The prizes will be announced via the Facebook event of the Global Tower and at the Facebook event of the Photo Contest.



2 Applicants

Only those can register for the contest who are 18 or older, has a real e-mail address, is a private individual and has a daytime or correspondent student status, and does not belong to the category stated at point 3. One person can register more than one Picture. With registration for the Photo Contest, the applicants approve everything which is stated in this document completely. Besides this, the applicants approve that neither DEHÖK EHKB nor ESN Debrecen nor AIESEC can be held accountable for any excuse or complaint concerning the prizes.

3 The ones who cannot apply

The members of DEHÖK EHKB, ESN Debrecen and AIESEC

4 The judgment of the submitted photos.

The sent images will be judged by the members of DEHÖK EHKB and AIESEC Debrecen together. They will choose the pictures for each topic, which symbolize the best of the given topic.

5 Notifying the winners

The winners will be notified via the e-mail address they gave during the registration at the 30th of April. The winners must check in with the organizers the day after the winners were announced with a reply to the notification email. If they fail to do so then in the given category based on the organizer's previous judgment, the application next in line will be announced as the winner of that category.

6 The transfer of the prizes

The prizes cannot be transferred.

7 Receiving the prizes

The prizes can only be received at the official award show of the Global Tower event. The award show will take place after the Talent Show and the Hungarian Culture Show. The winners automatically renounce their prizes and acknowledge the fact that they can not live with any claim against the organizers if they do not attend at the award ceremony personally. The planned time of the award show is 20:00 however, the exact starting time depends on the length of the previous programmes so the organizers uphold the right to change the schedule as they see fit, of which the winners will be notified via e-mail.



8 Data handling

The applicants acknowledge that the name, e-mail address and the photo they shared during registration will be stored and handled for the sake of the event. The data above will be stored in the servers of ESN Hungary and the service of Google Drive. With accepting this regulation, the applicant also accepts Google's Privacy Policy automatically as well.

The data will not be stored after the Photo Contest, except the data of the winners. The data of the winners will be stored for another 30 days by DEHÖK EHKB.

The applicants can always ask to terminate their registration for the Photo Contest by sending an e-mail to debrecen@esn.hu. Furthermore, their data can be deleted, modified and terminated after their request. The deletion of the photo or the data automatically disqualifies the applicant from the Photo Contest.

9 General Rules

DEHÖK EHKB upholds the right that the conditions of this regulation or the Photo Contest itself – during the application period as well – can be modified, suspended and terminated unilaterally. DEHÖK EHKB and AIESEC have the right to disqualify any applicant from the Photo Contest, especially if any suspicion emerges of abuse or violation of the regulations connected to the Photo Contest, or if any of the applicants manipulates the Contest or act in bad faith, furthermore in unforeseen circumstances or case of vis major. Besides these, every application will be disqualified if it contains obscene imagery or it violates the generally accepted social values. DEHÖK EHKB and AIESEC uphold the right to identify if the application does belong to the aforementioned two categories or not. The applicant must accept that the disqualification from the Photo Contest is final.

Any changes concerning the Photo Contest will be announced by DEHÖK EHKB at the Facebook page of DEHÖK EHKB. It is the applicant's responsibility to inform themselves properly. DEHÖK EHKB and AIESEC uphold the right to delete any comment concerning the Contest that violates public morality, others' religious, denominational or ethnic affiliation, any other rights or laws, etc. Violates the interest and reputation of DEHÖK EHKB, ESN Debrecen or AIESEC or violates the regulations of the Photo Contest, DEHÖK EHKB, ESN DEBRECEN, AIESEC can delete any insult from the Facebook page of DEHÖK EHKB, ESN Debrecen, AIESEC or from the Facebook event of the Global Tower, or disqualify the applicant who shared the comment. For any incidental offensive comment, only the applicant can be held responsible for the
